

It is with deep joy that I report another milestone for the 2017-2018 season that we had not seen coming — an impressive leap in our community outreach partnerships. I can tell you from years of experience that we will see powerful benefits from the arts touching so many more lives.

As always, our work here happens because of donors like you. Look around The Straz, read through the pages of this report and you will see the tangible effect you personally have on this community through your commitment to The Straz. We couldn't — and wouldn't — be here without you.

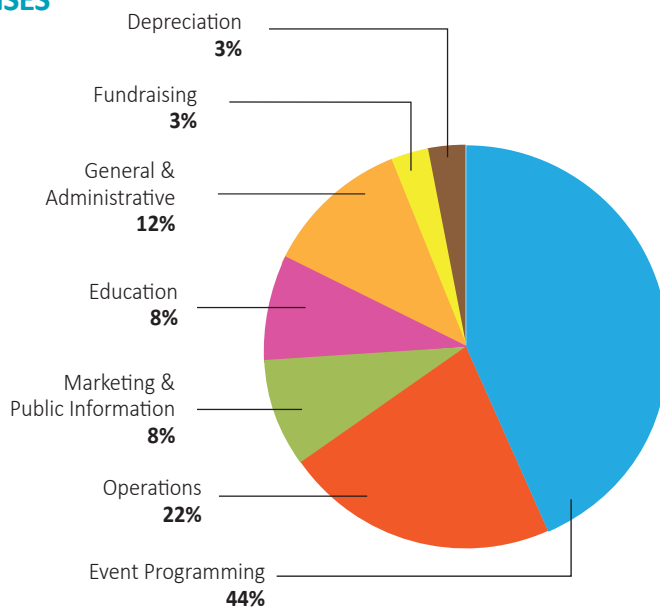
